## **Request for Parental Consent for APAAR (Automated Permanent Academic Account Registry)**

**Dear Parents,**

We hope this message finds you well.

As part of the One Nation, One Student ID initiative launched by the Government of India, the Automated Permanent **Academic Account Registry (APAAR)** system has been introduced under the **National Education Policy (NEP) 2020**. The APAAR system provides a unique 12-digit APAAR ID for each student, which will serve as a permanent digital identity in the Indian education ecosystem. This ID will allow students to securely store and manage their academic records such as scorecards, marksheets, degrees, diplomas, and co-curricular achievements.

We require your consent to register your child for the APAAR system.

**Please find the APAAR Consent Form enclosed with this circular.** A hard copy of the form has also been handed over to your child. Kindly review the form, sign it, and return it to the school along with a copy of your child's Aadhar card by **5th December 2024**.

### **Important Instructions:**

1. Please ensure that the signed form is returned by the deadline of 5th December 2024.
2. A copy of your child's Aadhar card must also be submitted along with the consent form mentioning the purpose that the copy is to be used only for the purpose of APAAR CARD id generation.

Your consent is required for us to register your child's academic information in the APAAR system, enabling them to benefit from a secure, digital academic record.

## Common Misconceptions about APAAR:

**APAAR data is not securely stored:** All APAAR ID related details, information is securely stored and transmitted only through authorized government databases. APAAR ensures full compliance with all the data protection, encryption, and data security guidelines prescribed in the Personal Data Protection Bill. UDISE+ and Digi Locker platforms have added layers of security that APAAR information is only shared with users having authorized access. Also, consent from parents/guardian is being recorded for data sharing.

# Common Misconceptions about APAAR:

**APAAR ID Generation is a complex procedure:** The Ministry of Education through multiple considerations and pilot studies have devised a process flow that only leverages the existing systems to generate APAAR ID for students. UDISE+ will be the end-to-end portal for responsible for generation of APAAR ID. As school students are minors and legally required parental consent to share their details to a third party, the multilingual consent form will be distributed, collected, and stored by the school authorities through the Parent Teacher Meetings (PTM) called in a staggered manner. Generation of APAAR ID and distribution of the details will be done after the PTMs in the subsequent working days by the class teacher. A confirmation SMS will also be sent to the registered mobile number for validation upon successful generation of APAAR ID.

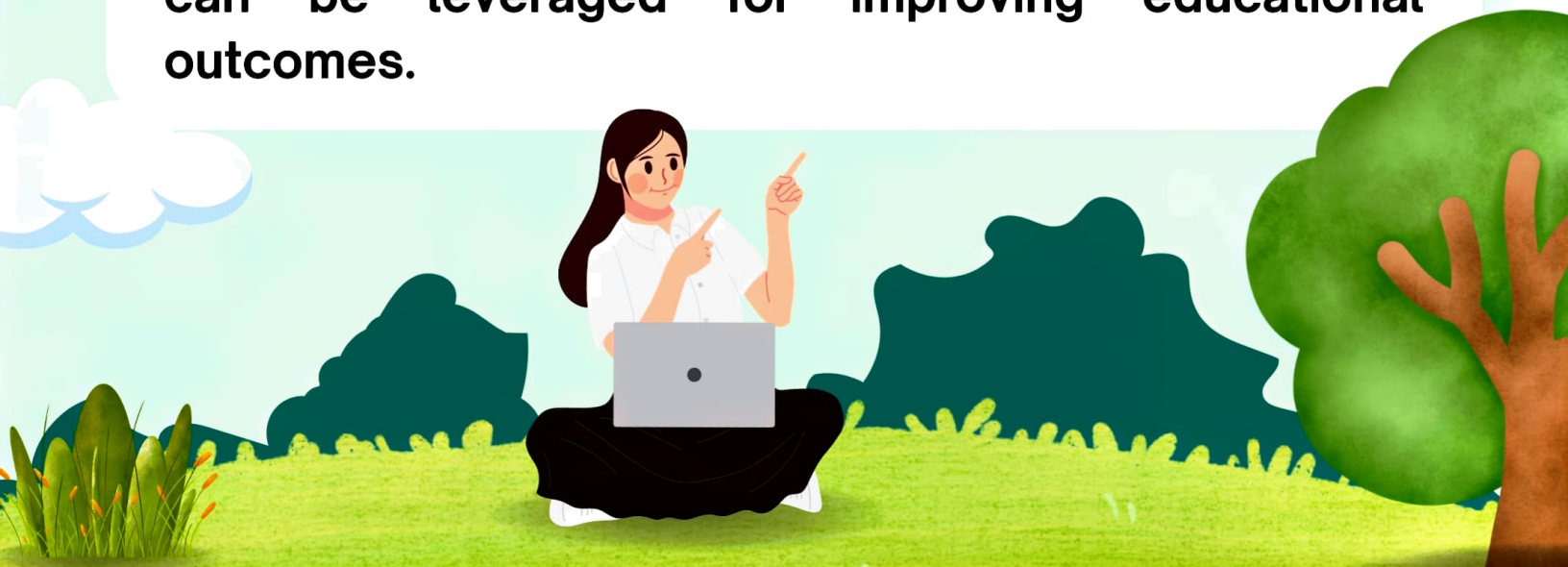
